

ORDINANCE NO. 2024-11

**AN ORDINANCE PROVIDING FOR THE COMPENSATION OF APPOINTED OFFICIALS OF THE  
CITY OF WICKLIFFE, OHIO; AND REPEALING ANY AND ALL OTHER ORDINANCES  
OR PARTS THEREOF THAT MAY BE INCONSISTENT WITH THIS ORDINANCE**

**WHEREAS**, Council of the City of Wickliffe, Ohio is of the opinion that it is in the best interest of the City and to the orderly operation of all departments of the City to adjust the salaries of certain employees of the City.

**NOW THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,  
COUNTY OF LAKE, STATE OF OHIO:**

**SECTION 1.** That effective January 1, 2024, the following compensation shall be paid to persons employed by the City of Wickliffe and performing the duties of:

Position	Yearly Salary
Chief of Police	\$123,000.00
Chief of Fire	\$123,000.00
Director of Finance	\$94,300.00
Assistant Finance Director	\$70,000.00
Police Prosecutor	\$50,000.00
Director of Public Service	\$94,052.98
Assistant Director of Public Service	\$81,603.33
Building Commissioner	\$93,920.75
Director of Public Safety*	\$18,500.00
Director of Recreation	\$82,966.58
Director of Law**	\$76,875.00

\*Or person acting as Director of Public Safety

\*\*Should any special representation be required beyond the normal scope of duties, upon recommendation of the Mayor, such representation and compensation for such services shall be subject to formal approval by Council in advance.

**SECTION 2.** That all compensation specified herein as a yearly salary shall be paid in equal biweekly installments.

**SECTION 3.** That this ordinance repeals any and all other ordinances or parts thereof that may be inconsistent with this ordinance.

**SECTION 4.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.




