

ORDINANCE NO. 2024-16

**AN ORDINANCE PROVIDING FOR THE COMPENSATION OF CERTAIN EMPLOYEES
OF THE CITY OF WICKLIFFE, OHIO AND REPEALING ANY AND ALL OTHER ORDINANCES
OR PARTS THEREOF THAT MAY BE INCONSISTENT WITH THIS ORDINANCE**

WHEREAS, Council of the City of Wickliffe, Ohio is of the opinion that it is in the best interest of the City and to the orderly operation of all departments of the City to adjust the salaries of certain employees of the City.

**NOW THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That effective January 1st, 2024, the following compensation shall be paid to the persons employed by the City of Wickliffe and performing the following duties:

Whenever a minimum and a maximum scale is established herein, the Mayor shall determine the salary of each employee within such minimum and maximum limits.

SECTION 2. That this ordinance repeals any and all other ordinances or parts thereof that may be inconsistent with this ordinance.

SECTION 3. That the compensation specified in Section 1 hereof, as it applies to yearly paid employees, is for the entire swimming pool season. In the event an employee is unable to work the complete swimming pool season or is employed subsequent to the commencement of the swimming season, then the compensation shall be adjusted accordingly. Each day's adjustment shall be calculated at 1/70th of the compensation provided for in Section 1 hereof.


