

ORDINANCE NO. 2024 – 22

AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE NEW DUMP BODY AND HYDRAULIC PACKAGE THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES OFFICE OF STATE PURCHASING, FOR USE BY THE SERVICE DEPARTMENT OF THE CITY OF WICKLIFFE, OHIO; AND DECLARING AN EMERGENCY

WHEREAS, Resolution No. 1986-34 authorizes the Mayor of the City of Wickliffe, Ohio to purchase certain equipment through the Ohio Department of Administrative Services, Office of State Purchasing, pursuant to Ohio Revised Code Section 125.04; and

WHEREAS, the purchase of certain equipment through said office is in compliance with the provisions of the Charter of the City of Wickliffe, Ohio relative to competitive bidding; and

WHEREAS, Council is advised by the Administration that it is necessary to acquire one new dump body and hydraulic package including installation on the City's new truck chassis for use by the Service Department of the City of Wickliffe, Ohio.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized to purchase through the Ohio Department of Administrative Services, Office of State Purchasing, per quote from Concord Road Equipment Mfg., Inc., 8200 Tyler Blvd. Suite H, Mentor Ohio 44060, one new dump body and hydraulic package to be installed on a new truck chassis supplied by City of Wickliffe, per Schedule Number 800925, Index Number STS515, in a net amount not to exceed eighty-four thousand, ninety-six dollars and forty-five cents (\$84,096.45).

SECTION 2. That the Director of Finance be and is hereby authorized to issue payment to Concord Road Equipment Mfg., Inc., 8200 Tyler Blvd. Suite H, Mentor Ohio 44060, in an amount not to exceed eighty-four thousand, ninety-six dollars and forty-five cents (\$84,096.45) from the Capital Fund for said equipment.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city, and for the further reason that the purpose of said equipment is necessary for the daily operation of the Service Department; wherefore, this ordinance provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
