

**AN ORDINANCE AUTHORIZING THE PURCHASE OF TWO (2) NEW CURRENT MODEL VEHICLES
FOR USE BY THE POLICE DEPARTMENT OF THE CITY OF WICKLIFFE, OHIO,
THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE
PURCHASING PROGRAM; AND DECLARING AN EMERGENCY**

WHEREAS, Resolution No. 1986-34 authorizes the Mayor of the City of Wickliffe to purchase certain equipment through the Ohio Department of Administrative Services Cooperative Purchasing Program, pursuant to Ohio Revised Code Section 125.04. The purchase of certain equipment through said office is in compliance with the Charter of the City of Wickliffe relative to competitive bidding; and

WHEREAS, Council is advised by the Administration that it is necessary to acquire two (2) new 2024 Ford Utility Interceptors for use by the Police Department.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF
THE CITY OF WICKLIFFE, COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized to purchase through the Ohio Department of Administrative Services Cooperative Purchasing Program, per quote of Chapman Ford of 1255 Columbus Avenue, Marysville, OH 43040, two (2) new 2024 Ford Utility Interceptors for a total amount not to exceed Ninety-Two Thousand Four Hundred Seventy-Six Dollars (\$92,476.00), per specifications and proposals on file in the office of the Chief of Police.

SECTION 2. That the Director of Finance be and is hereby authorized to issue payment to Chapman Ford of 1255 Columbus Avenue, Marysville, OH 43040, for a total amount not to exceed Ninety-Two Thousand Four Hundred Seventy-Six Dollars (\$92,476.00) for the vehicle from the Capital Fund upon approval of the Mayor.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city, and for the further reason that the purchase is necessary for the daily operation of the Police Department; wherefore, this ordinance provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
