

ORDINANCE NO. 2024 – 27

**AN ORDINANCE AUTHORIZING THE DIRECTOR OF FINANCE
OF THE CITY OF WICKLIFFE, OHIO TO TRANSFER A SUM OF MONEY FROM THE
GENERAL FUND TO VARIOUS FUNDS; AND DECLARING AN EMERGENCY**

WHEREAS, it has been determined necessary to transfer sums of money from the General Fund to the Safety Services Fund, the Swimming Pool Fund, and the Capital Project Fund; and

WHEREAS, pursuant to the Charter of the City of Wickliffe, Council may transfer sums of money from one fund to another.

**NOW, THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That Council hereby transfers the sums indicated below:

<u>From</u>	<u>To</u>	<u>Amount</u>
General Fund	Safety Services Fund	\$ 5,316,000.00
General Fund	Swimming Pool Fund	\$ 245,000.00
General Fund	Capital Project Fund	\$ 1,041,660.00

SECTION 2. That the Director of Finance be and is hereby authorized to transfer amounts for a total not to exceed the amount indicated in Section 1 hereof.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the City and its inhabitants; wherefore, this ordinance, provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
