

ORDINANCE NO. 2024-28

**AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF WICKLIFFE, OHIO
TO ENTER INTO A CONTRACT WITH PERFORMANCE PIPELINING, INC. FOR THE
DRENIK DRIVE SANITARY SEWER LINING PROJECT; AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to advertisements, which appeared in *The News-Herald*, a newspaper of general circulation in the County of Lake and the City of Wickliffe, Ohio, proposals were received for the project entitled Drenik Drive Sanitary Sewer Lining Project; and

WHEREAS, Council is of the opinion that the bid submitted by Performance Pipelining, Inc., 1551 W. Norris Drive, Ottowa, IL 61350 is the lowest and best bid.

**NOW THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**


SECTION 1. That the Mayor be and is hereby authorized to enter into a contract with Performance Pipelining, Inc., 1551 W. Norris Drive, Ottowa, IL 61350, for Drenik Drive Sanitary Sewer Lining Project in an amount not to exceed Seven Hundred Eighty-Two Thousand, Five Hundred Seventy Dollars (\$782,570.00) in accordance with the specifications on file in the office of the Clerk of Council and in the office of the City Engineer.

SECTION 2. That the Director of Finance is hereby authorized to disburse payment to Performance Pipelining, Inc., 1551 W. Norris Drive, Ottowa, IL 61350, in an amount not to exceed Seven Hundred Eighty-Two Thousand, Five Hundred Seventy Dollars (\$782,570.00) upon approval of the Mayor. Said funds to be disbursed from the American Rescue Plan Fund.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city; wherefore, this ordinance, provided it receives an affirmative vote of two thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.


