Reports and Communications from Mayor/Safety Director

Mayor Sakacs read his written report.

There were no questions for the Mayor.

Reports and Communications from Director of Law

Law Director Iosue had nothing to report.

Reports and Communications from Council President

Council President Levon was excused and had no report.

Additions or Amendments to Agenda

Council President Pro Tem Jaworski added New Late September Event to New Business Item B. and WCSD Communication to New Business as Item C., both as requested by Mayor Sakacs in his written report.

Administrators

A. *Police Chief (Bush)* Written Report Submitted

Chief Bush reported back to Councilperson Bala regarding the Block Watch meeting. He noted is has been scheduled for May 16th, 2024 at 7:00PM at the Police Department. The topics include a K-9 demonstration and Safety Tips for residents.

The Chief noted there has been some mis-information on social media; there have been reports of problems with burglaries/break-ins on the north end. Chief Bush stated this is untrue. He has reviewed reports over the last month and there have been none. He has increased patrols to "set minds at ease", but it is mis-information.

Councilperson Bala questioned a shut-down of the Rt. 2 exit ramp today. Chief Bush noted he was unaware of any issues, and Chief Grossman noted it was a brush fire along the freeway that the Fire Department was addressing; the police car was to block traffic for the Fire Department.

There were no further questions or comments for the Police Chief.

B. *Fire Chief (Grossman)*

Chief Grossman reported there was a brush fire along Rt.2. He took the opportunity to remind all that there is a lot of dry matter at this time of year. He noted the open burn policy is on the website, but that people should be extra careful as dry material is easily ignitable.

There were no questions or comments for the Fire Chief.

C. *Finance Director (Hunter)*

Finance Director Hunter noted in 2019, the City granted an exemption of sewer fees to Umicore Specialty on Lakeland Boulevard. It has been requested that this exemption be revoked. The Engineer, Service Director, and Fire Chief are looking into this and once all have completed their review, they will come back to Council with a recommendation.

There were no questions or comments for the Finance Director.

D. *Engineer (Formica)* Written Report Submitted

Engineer Formica reported the 296th Street project is going along well. He and the Service Director had an onsite meeting there a week ago. He noted there is an extensive amount of base repair necessary, and the contractor is pricing a new concrete road vs. the concrete gutter and curbs with asphalt, as it may be a better solution. He and the Service Director are reviewing the quote, then will be coming to Council with a recommendation.

Council President Pro Tem Jaworski asked for a percentage estimate of the amount of the street that may require this. Engineer Formica noted he would like to discuss this in committee.

Councilperson Gerhardstein noted the budget is on final reading tonight and wondered if the road project bids are ready to begin if the budget is passed. Mr. Formica noted he is on top of it.

There were no further questions or comments for the Engineer.

E. *Service Director (Strauser)*

Service Director Strauser noted there are a few pieces of legislation on tonight's agenda regarding capital improvements, once the budget is passed. The dump body and salt spreader package is for the new truck that arrived today. Councilperson Gerhardstein asked if this is the truck body that was ordered last year, and Mr. Strauser noted that to be correct.

Councilperson Gerhardstein also asked who is responsible for contacting the County regarding lights that are out along Rt. 2. The Service Director noted he could do so. Mr. Gerhardstein noted most of the lights are out. Mr. Strauser noted there have been multiple meetings on this. The County's explanation is that they are having problems with the lighting contractor; it is an issue in the County engineer's hands. Mr. Gerhardstein asked if it is part of the Rt. 2 maintenance fee that we pay, and Mr. Strauser noted it is, but we are billed for what they do and the past few years it has been way under budget for us. Mr. Gerhardstein asked that someone reach out again about the lights. Mayor Sakacs noted they have been contacted. He noted he has attended many meetings where this has been discussed and the County engineer, who is an

elected official, does not respond. He noted the Commissioners are also not getting a response and he has heard this person does not care. Service Director Strauser noted the service provided is not like it used to be. Mayor Sakacs noted litter pick up on the ramps is not getting done, and a few organizations have volunteered to do clean ups here. Council President Pro Tem Jaworski noted this is a shame. Councilperson Koski noted Keep Wickliffe Beautiful has also performed clean ups of the freeway exit ramps. Service Director Strauser noted he assigned third shift to do clean up there one time for approximately four hours and the next day it was so bad you couldn't tell it had been cleaned.

Councilperson Bala inquired regarding getting street striping done earlier this year. Mr. Strauser noted he does plan to begin this earlier. He had that same intention last year, but there were problems getting the reflective paint. He has already been looking into this and there will not be issues with acquiring paint this year so he anticipates this project to be completed sooner rather than later.

Councilperson Gerhardstein asked if landscaping companies are permitted to sponsor a flowerbed, and add their signage. Mr. Strauser stated it is ultimately the Mayor's decision, but noted he would not have a problem with it, as long as the company does not put in extensive plantings and they maintain it throughout the year. Mr. Gerhardstein noted it is the planters at Lloyd and Euclid.

There were no further questions or comments for the Service Director.

F. *Building Commissioner (Sack)*

Building Commissioner Sack had nothing to add to his previously submitted Written Report.

Councilperson Koski asked if Dino was out looking at roofs, etc. on people's houses. Mr. Sack noted that yes, they have begun this last week.

There were no additional questions or comments for the Building Commissioner.

G. *Recreation Director (Stopp)*

Recreation Director thanked all who supported the Easter Egg Hunt. He noted that, despite the snow, there were a few hundred people who attended, as well as the Easter Bunny and the Easter Armadillo from Texas Roadhouse.

Council President Pro Tem Jaworski offered kudos to the Rec. Department and volunteers, noting other cities cancelled their events due to weather.

There were no other questions or comments for the Recreation Director.

Audience Participation

Council President Pro Tem Jaworski opened Audience Participation to those in attendance at 7:16 PM.

He noted this portion of the meeting is intended for the audience to address the Council and Mayor, not the directors. Anyone wishing to address Council should use the microphone as the meetings are being streamed on YouTube; they must be acknowledged and give their name and address for the clerk's record and will be given a five minute maximum for their comments.

Jeff Butler of 660 Sterling Road stated he is a member of the Planning Commission. With regard to the School Property, he noted his disappointment. The Planning Commission spent a great deal of time discussing this property, as they recognize it's importance to the City. They came to what they felt was the best decision which was the recommendation of the R1-60 lots. He noted Council held a Public Hearing and not all Council Members attended, but he's heard that Council now wants to "scrap the plan". He stated that buyers will not design a plan then present it before they own the property. He is curious as to why this was not brought up at the Hearing. Councilperson Gerhardstein noted he attended all the meetings (Mr. Butler noted Mr. Jaworski was also in attendance) and he 100% supported the recommendation of the Planning Commission at both Public Hearings. Mr. Butler asked for an explanation as to the thought process behind "leaving it as it is" and "hoping someone shows up". Council President Pro Tem Jaworski noted he has not changed his stance since the beginning, and Mr. Butler noted he knows where Mr. Jaworski stands and respects his position 100%. Councilperson Salotto noted she had work responsibilities and was unable to attend. She respects what [Planning Commission] has done, and they have done a great job. She noted some on the Council were hoping for "a little more meat to the presentation". She suggested there could have been more about what the homes would look like, the cost of the homes, etc., which she noted developers are often able to provide. She said they were "looking for more" detail regarding the sixty-foot lots. Mr. Butler noted those are not the details that can be required at this point. He also noted his concern is that it would become another Ponderosa that "just sits there". If it is not zoned, it sells for less, which

means more taxes down the road. He noted it would be in our best interest to work with the schools and do what would be the most beneficial to the schools and ourselves. Ms. Salotto noted they are thinking about the tremendous opportunity in the center of the city to put something remarkable there that can also help the city and reset things moving forward. She noted no one is really against this. Mayor Sakacs noted when we get to New Business, he believes that letter will have something that Council will like. Councilperson Bala agreed with the sixty-foot frontages and noted he does not want the property to be sitting there. He noted it is wrong of some council members to ask for pictures, as there were examples given of area developments that were offered for review. He noted they should have gone and driven through them. Councilperson Koski noted she was against the [R1-]50s but thinks the [R1-]60s are a good balance. She noted the Engineer did provide some pictures and she is not against the 60s. Mr. Butler noted his impression is that since they aren't sure about the 60s, they are willing to leave [the property] in limbo.

Gail Willis 28979 Sherbrook is a twelve-year member of the school board. She noted they have been working on this for a long time and is disappointed in hearing the negativity on this. She suggested it will turn into a Ponderosa that will sit there. She noted a lot of work has gone into this, especially Joe Speccia. She suggested some have not attended any of the Planning Commission meetings. She also noted there was a lot of positivity and discussion about what people will buy and what the market will bear. She noted it will be taking money away from the community. She stated it is a shame that anyone would be negative. Examples were given and if some did not do their due diligence it is unfortunate, and disappointing. She noted there are currently about six developers, but none will create a plan at this point. She added Mr. Levon noted at a previous meeting that whoever purchases the property will have to bring forward to and have approved by Council a plan for the property. She restated her disappointment in some of the Councilmembers.

After multiple calls inquiring if anyone would like to address Wickliffe City Council and there being no reply, Council President Pro Tem Jaworski closed Audience Participation at 7:26PM.

A. Bid Presentation – Drenik Drive Sanitary Sewer Lining

Engineer Formica presented the results from the bid opening held on March 1st, 2024. Three bids were received and the low bidder was Performance Pipelining, a company out of Illinois. Mr. Formica noted he had not worked with this company but called all the references. All spoke very highly of the company, comparing them to known local companies that have similar reputations, which was reassuring. He recommends this contract be awarded to Performance Pipelining. He reminded all that the project is being funded by ARPA funds, a grant, and funding received by the Finance Director, which should total approximately 100%.

Norris Drive, Ottawa, IL 61350, for the Drenik Drive Sanitary Sewer Lining Project in an amount not to exceed Seven Hundred Eighty-Two Thousand Five Hundred Seventy Dollars (\$782,570.00) as the lowest and best and to reject all other bids; and authorize the Law Director to prepare legislation to authorize the Mayor to enter into a contract with Performance Pipelining, Inc. for the Drenik Drive Sanitary Sewer Lining Project.


