

ORDINANCE NO. 2024 – 30

**AN ORDINANCE THAT REPEALS, *IN TOTO*, ORDINANCE NO. 2019-17, PASSED
FEBRUARY 25, 2019; AND DECLARING AN EMERGENCY**

WHEREAS, Ordinance numbered 2019-17 titled, “AN ORDINANCE APPROVING THE EXEMPTION OF SANITARY SEWER UTILITY SERVICES TO UMICORE SPECIALTY MATERIALS RECYCLING, LLC FOR WATER THAT IS NOT RECEIVED BY THE CITY OF WICKLIFFE SEWER SYSTEM; AND DECLARING AN EMERGENCY” addressed an application for the exemption of sanitary sewer utility fees for water that is not received by the City’s sanitary sewer system; and

WHEREAS, Council granted the exemption of sanitary sewer utility fees to Umicore Specialty Materials Recycling, LLC, 28960 Lakeland Blvd., Wickliffe, Ohio, “for water that is not received by the City’s sanitary sewer system, based on a letter submitted by the City Engineer dated October 12, 2018 and the documentation identified as *Exhibit A* attached hereto and incorporated herein” with OR019-17 passed on February 25, 2019; and

WHEREAS, a request from the property owner, Vadakin Family Limited Partnership, was received by the Finance Director of the City of Wickliffe regarding the removal of the sewer meters installed for Umicore at 29860 Lakeland Boulevard, Wickliffe, Ohio; and

WHEREAS, Wickliffe City Council has learned that the Limited Liability Corporation, Umicore Specialty Materials Recycling is no longer a licensed business per office of the Secretary State of Ohio.

**NOW THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That Ordinance numbered 2019-17, passed February 25, 2019, is hereby repealed *in toto*.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city; wherefore, this ordinance, provided it receives an affirmative vote of two thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.


