

**AN ORDINANCE AMENDING CHAPTER 935 SEWER REGULATIONS AND RATES  
OF THE CODIFIED ORDINANCES OF THE CITY OF WICKLIFFE, OHIO**

WHEREAS, City Council has determined that amending Chapter 935 Sewer Regulations and Rates of the Codified Ordinances of the City of Wickliffe, Ohio would be in the best interest of the residents of the City.

**NOW, THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,  
COUNTY OF LAKE, STATE OF OHIO:**

**SECTION 1.** That Chapter 935 Sewer Regulations and Rates of the Codified Ordinances of the City of Wickliffe is hereby amended to read as follows:

935.06 UNPAID CHARGES CERTIFIED TO COUNTY AUDITOR FOR COLLECTION.

**Annually**, every sewer service or rental charge which has become due and payable and has remained ~~unpaid for more than ninety (90) days or more delinquent thirty days prior to the first day of July each year~~, shall be certified by the Director of Finance to the Lake County Auditor on or before the second Monday in September of each year together with a pertinent description of the premises to which the sewer service or rental charge has been made. The amounts certified will be in accordance with Ohio Revised Code. The amounts so certified shall be placed by the Auditor on the tax duplicate of the County to be collected as other taxes are collected. In addition to such collection procedure, any such unpaid amount may be collected through civil action brought in the name of the City in any court of competent civil jurisdiction.

**SECTION 2.** That this ordinance repeals any and all other ordinances or parts thereof that may be inconsistent with this ordinance.

**SECTION 3.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
