

ORDINANCE NO. 2024 – 31

**AN ORDINANCE AMENDING A SECTION OF CHAPTER 521 ENTITLED
HEALTH, SAFETY, AND SANITATION OF THE CODIFIED ORDINANCES
OF THE CITY OF WICKLIFFE, OHIO**

WHEREAS, Wickliffe City Council has made recommendations relative to amending to Chapter 521.12 Roadside Stands Prohibited, a section in Chapter 521 – Health, Safety, and Sanitation of the Codified Ordinances of the City of Wickliffe, Ohio; and

WHEREAS, Council has determined the recommended changes would be in the best interest of the residents of the City of Wickliffe.

**NOW THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That Section 521.12 – Roadside Stands Prohibited, a section within Chapter 521 Health, Safety and Sanitation, of the City of Wickliffe Codified Ordinances is hereby amended to read as follows:

521.12 ROADSIDE STANDS PROHIBITED.

- (a) **Except as outlined in Chapter 521, Section 521.17**, No person shall keep or maintain any roadside stand within the City where flowers, vegetables, foodstuffs or any other items or commodities are kept, sold or bartered.
- (b) For the purpose of this section, a truck, car or other vehicle that parks or remains in, or on the roadway or at one location for the purpose of such activity defined in subsection (a) hereof, shall be considered a roadside stand and in violation of this section.
- (c) Nothing in this section shall prohibit delivery trucks or house to house sales by properly licensed peddlers.
- (d) Whoever violates this section is guilty of a minor misdemeanor.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
