

**RESOLUTION NO. 2024 – 12**

**A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF WICKLIFFE, OHIO TO  
SUBMIT AN APPLICATION TO LAKETRAN FOR FUNDING THROUGH THE TRANSIT  
ACCESSIBILITY GRANT PROGRAM; AND DECLARING AN EMERGENCY**

**WHEREAS**, Laketran has made available funding for the competitive Transit Accessibility Grant; and

**WHEREAS**, the City of Wickliffe has a needed infrastructure project for which funding is desired; and

**WHEREAS**, the City of Wickliffe wishes to submit an application in 2024 to secure grant funding; and

**WHEREAS**, the estimated project cost is \$267,300.00; the City is requesting grant funding in the amount of \$187,110.00 leaving an estimated City share of \$80,190.00; and

**WHEREAS**, along with the request for funding, a resolution of authorization from City Council for the filing of the application is beneficial to the project.

**NOW, THEREFORE, IT IS RESOLVED BY THE COUNCIL OF THE CITY OF WICKLIFFE,  
COUNTY OF LAKE, STATE OF OHIO:**

**SECTION 1.** That the Mayor be and is hereby authorized to prepare and submit an application on behalf of the City of Wickliffe for the Laketran Accessibility Grant Program funding for Johnson Drive, Cabin Drive, and Clark Drive Sidewalk Improvements.

**SECTION 2.** That the Mayor be and is hereby authorized to execute such forms and contracts as may be required to properly secure said funding.

**SECTION 3.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the city and its inhabitants; and for the usual daily operation of the City for the reasons set forth and defined in the preamble to this resolution; wherefore, this resolution, provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
