

ORDINANCE NO. 2024 – 47

**AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE NEW
PLAYGROUND STRUCTURE AND ADDITIONAL PLAY PANELS, INCLUDING
INSTALLATION, FROM SNIDER RECREATION, INC. FOR ORLANDO PARK
IN THE CITY OF WICKLIFFE, OHIO; AND DECLARING AN EMERGENCY**

WHEREAS, various proposals were received for the purchase of a new playground structure to be installed at Orlando Park in the City of Wickliffe, Ohio; and

WHEREAS, Council was advised by the Administration the new equipment is to replace a twenty-five year old piece of equipment at Orlando Park; and

WHEREAS, a discussion was held regarding the new structure; Council approved the purchase of the new structure designed for children age five through twelve and having handicap accessible features; the total price includes the cost of installation of the equipment.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized to purchase per quote from Snider Recreation, Inc, 10139 Royalton Road, Suite K, North Royalton, OH 44133, one new BCI Burke "Nucleus" playground equipment with additional panels including freight and installation in a net amount not to exceed Fifty-Six Thousand, Dollars (\$56,000.00).

SECTION 2. That the Director of Finance be and is hereby authorized to issue payment to Snider Recreation, Inc, 10139 Royalton Road, Suite K, North Royalton, OH 44133 in an amount not to exceed Fifty-Six Thousand, Dollars (\$56,000.00) from the Capital Improvement Fund upon approval of the Mayor.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city, and for the further reason that the purchase of said equipment is time sensitive; wherefore, this ordinance provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.




