City Council Meeting Minutes June 24, 2024

Following the Pledge of Allegiance, the Mayor swore in a new Police Patrolman, Joseph A. Lehner: He welcomed the new Police Patrolman to Wickliffe.

A regular meeting of Wickliffe City Council was called to order by Council President Ed Levon on Monday, June 10, 2024 at 7:02 PM in Council Chambers at Wickliffe City Hall.

Mayor Sakacs thanked Mr. Cain for all his years of service to the Civil Service Commission. He noted the City is lucky to have a wonderful guy who was devoted to the City and this Commission. Councilperson Gerhardstein asked how many of the communities have adopted the LGF proposal. Mayor Sakacs noted he was unsure, as there have been no communications regarding this topic.

Council President Levon added Executive Session to discuss Personnel (per ORC 121.22 G1 to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official, or the investigation of charges or complaints against a public employee, official, licensee, or regulated individual, unless the public employee, official, licensee, or regulated individual requests a public hearing) as number nineteen (19) on the agenda and to move Adjournment to number twenty (20).

Administrators

A. Police Chief (Bush) *Written Report Submitted*

Chief Bush noted most may be aware there was a standoff yesterday on Worden at Phillips. It was resolved successfully and the suspect was charged with domestic violence and obstruction, and is not allowed back to the house.

There were no questions or comments for the Police Chief.

B. Fire Chief (Grossman)

Chief Grossman added this is the last week Doug Leovic. He has offered to help with the transition by coming back evenings or weekends if needed. They will make sure things go smoothly and plan to work with Building regarding occupancy permits. He and Capt. Isom will be handling plan reviews. They will look for a replacement once they get everything worked out. If anyone has questions, he is happy to answer them.

There were no questions or comments for the Fire Chief.

C. Finance Director (Hunter)

Finance Director Hunter had nothing to report.

There were no questions or comments for the Finance Director.

D. Engineer (Formica) *Written Report Submitted*

Engineer Formica was excused.

There were no questions or comments for the Engineer.

E. Service Director (Strauser)

Service Director Strauser noted his Annual Report was submitted on Board Docs.

Mr. Strauser noted there is an ordinance on tonight's agenda regarding the lining of 600 feet of sewer pipe on Palisades Parkway which has had root issues. The company currently working on the Drenik Drive project offered advantageous pricing as they are currently working in the city. If Council prefers, he can look for other quotes, but we will lose this offer. This project is being funded with ARPA funds. Councilperson Jaworski noted this area has been a problem for years, and wondered if this will be the "fix" or if it will require additional lining. Mr. Strauser noted sections have been replaced previously, and there is additional work that will be necessary along the tracks, but this should take care of it. Councilperson Gerhardstein noted he read the Annual Report and it was "pretty amazing" with regard to what gets done with the amount of staff we have; it is impressive.

There were no additional questions or comments for the Service Director.

F. *Building Commissioner (Sack)*

Building Commissioner Sack had nothing to report.

Councilperson Jaworski inquired regarding the old Sand Bar and the work that is currently being done there in the parking lot. He does not recall them coming to the Planning Commission to have plans approved. Mr. Sack noted it was in the plans. Mr. Jaworski asked how long ago, and Mr. Sack noted that it was long ago. He stated he can pull the plans for Mr. Jaworski. Mr. Jaworski wondered if the plans should have a time limit on them, adding that if the plans are old, they may not comply with current code requirements. Mr. Sack noted there is nothing that states plans must be complete in a certain amount of time, however work must begin within twelve months after the Planning Commission has approved the plans. Mr. Jaworski asked the Law Director if he is aware of other communities who may have time limits associated with construction/approval of plans. Law Director Iosue noted it would likely be a "reasonable" amount of time. Mr. Jaworski noted his concern is that Ordinances and Code changes, and he believes that something taking more than ten years may not be "up to code". Councilperson Salotto agreed and believes it is incumbent upon us in the future to place limits on plan approval to stay current. Mr. Iosue noted we could certainly add something. He noted he does not believe there is anything about this in our current code. Mr. Gerhardstein noted there were large blocks there that have been removed and a curb has been poured. He noted this could not have been in the plans. Mr. Sack noted he will check them out.

There were no further questions or comments for the Building Commissioner.

G. *Recreation Director (Stopp)*

Recreation Director was excused.

There were no questions or comments for the Recreation Director.

Audience Participation

Council President Levon opened Audience Participation to those in attendance at 7:18 PM.

He noted this portion of the meeting is intended for the audience to address the Council and Mayor, not the directors. Anyone wishing to address Council should use the microphone as the meetings are being streamed on YouTube; they must be acknowledged and give their name and address for the clerk's record and will be given a five-minute maximum for their comments.

Michael Nadolski of 1532 Maple Street came up to see if golf carts could be allowed to drive on the roads. He has done research on this topic. He noted other cities are allowing this, and he is aware that there are certain requirements for safety including inspections, etc. Council President Levon noted in the fifteen years he's been on Council it has never been discussed. Councilperson Gerhardstein noted he spoke with Mr. Nadolski, and then went to the Police Department. He noted he did not have the ORC that outlawed them, but allows communities to adopt their own rules regarding golf carts. The Wickliffe Police Department noted it would be a safety risk to have golf carts on our roads. He noted it can be adopted by the City, but the Police Department does not support this as it is a risk. Mr. Nadolski noted the state allows it. Mr. Gerhardstein noted the state does not allow them, but does allow each city to adopt legislation to make them legal. He also noted the Police Department is of the opinion this is a safety issue and Mr. Gerhardstein agreed. Mr. Nadolski noted it would be the same as a motorcycle, and wondered why it is not included with our ordinances. Mr. Levon noted it is not included because the state did not allow it. Mr. Nadolski noted the state has opened it up. Mr. Levon noted it seems the recommendation of the Police Department is to keep it illegal. He noted it could be put into committee for discussion. Mr. Nadolski wondered what would happen if he got his golf cart safety inspected, and all items to make it "legit" with a plate, etc., then drove down his street. Mr. Levon noted Council could investigate it, noting one of the reasons the state may have allowed it is due to the

many rural areas in our state where it may not be a problem. Mr. Nadolski noted it is allowed in Fairport, Geneva, Eastlake and Mentor-on-the-Lake. Mr. Levon noted he will add it to committee and look into it further. Mr. Nodolski noted he has a nice golf cart he'd like to use.

Jottie Allison of 1853 Kennedy Drive inquired if Kennedy Drive will be repaired anytime soon. Service Director Strauser responded that it is on the list for patching this year and then joint repair next year. He also added they will do some patching there this year.

After multiple calls inquiring if anyone would like to address Wickliffe City Council and there being no reply, Council President Levon closed Audience Participation at 7:24PM.

Mr. Gerhardstein noted he was unaware that our delay caused our residents to have to pay for the other city's portions.


