

ORDINANCE NO. 2024-53

**AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF WICKLIFFE, OHIO
TO ENTER INTO A CONTRACT WITH RELIANCE STANDARD LIFE INSURANCE COMPANY
FOR THE PROVISION OF LIFE INSURANCE COVERAGE FOR CERTAIN EMPLOYEES OF THE CITY;
AND DECLARING AN EMERGENCY**

WHEREAS, Council has determined that the best interests of the City would be served by providing a plan of life insurance coverage insuring certain employees of the City.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor is hereby authorized to enter into a contract commencing January 1, 2025 through December 31, 2025, with Reliance Standard Life Insurance Company for the provision of employee life insurance coverage.

SECTION 2. That the Director of Finance is authorized to make payments to Reliance Standard Life Insurance Company in accordance with the terms of the contract upon receipt of invoices approved by the Mayor.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of the ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said city, and for the further reason it is necessary for the efficient operation of city government; and the contract, affecting certain employees, is effective January 1, 2025; wherefore, this ordinance, provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
