

**RESOLUTION NO. 2024 – 17**

**A RESOLUTION APPROVING THE 2023 SOLID WASTE MANAGEMENT PLAN, UPDATED  
SEPTEMBER 2024, OF THE LAKE COUNTY SOLID WASTE MANAGEMENT DISTRICT;  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the Board of County Commissioners of Lake County has established the Lake County Solid Waste Management District (the “District”) and has established and convened a “Solid Waste Management Policy Committee” (the “Policy Committee”) in accordance with Section 3734 of the Revised Code to prepare a “Solid Waste Management Plan” (the “Plan”) for the District as required by Section 3734.54; and

**WHEREAS**, the Solid Waste Management District Policy Committee, pursuant to law, has reviewed the original Plan and it has issued a Plan Update for the original Plan. Further, said committee adopted the aforesaid Five-Year Solid Waste Plan Update on September 17, 2024; and

**WHEREAS**, upon receiving or determining approval of the Five-year Update Plan by: (1) the Lake County Commissioners; (2) the legislative authorities of the municipal corporation having the largest population within the boundaries of the county of the district; and (3) at least 60% of the population of the combined municipal corporations and townships within the district, the District Policy Committee must ratify the updated Solid Waste Management Plan prior to submitting it to Ohio EPA for approval.

**NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF WICKLIFFE,  
COUNTY OF LAKE, AND STATE OF OHIO:**

**SECTION 1.** That the Five-Year Solid Waste Plan Update (SEPT 2024) is approved in the form submitted to Council and presently on file with the Clerk of Council and the Administration.

**SECTION 2.** That the Clerk of Council is hereby authorized and directed to mail or otherwise deliver promptly a certified copy of this resolution to the Solid Waste Management District Coordinator.

**SECTION 3.** That all formal actions of this Council concerning the passage of this resolution were adopted in an open meeting, and that all deliberations of this Council or any of its Committees, which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the city and its inhabitants; and for the further reason that it is necessary to provide for the timely submission of said plan to the Solid Waste Management District Coordinator; wherefore, this resolution, provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.


