

ORDINANCE NO. 2024 – 60

**AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF WICKLIFFE, OHIO
TO ENTER INTO A CONTRACT WITH
THE FRATERNAL ORDER OF POLICE LODGE NO. 116 (SERGEANTS AND LIEUTENANTS);
AND DECLARING AN EMERGENCY**

WHEREAS, Council and the Administration have conducted extensive negotiations with the Fraternal Order of Police, Lodge No. 116, bargaining agent for Sergeants and Lieutenants of the City of Wickliffe Police Department; and such negotiations have provided a tentative agreement between the parties; and

WHEREAS, Council and the Administration have reviewed such proposal and do desire to ratify and adopt such Agreement.

**NOW, THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized and directed to enter into an agreement with the Fraternal Order of Police, Lodge No. 116, on behalf of Sergeants and Lieutenants of the Police Department, a copy of which is attached hereto and made a part hereof as though fully rewritten herein, marked "Exhibit A".

SECTION 2. That any and all ordinances in direct conflict with the express provisions of this Agreement are superseded by this Agreement.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city, and for the further reason that the immediate passage of this ordinance is necessary for the daily operation of a municipal department; wherefore, this ordinance provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
