Council President Levon noted no changes were made to this list from last year. He asked if any had objections to these assignments, and there were none.

Items to be Placed in Committee

The City Council Committee Task Assignments document, latest version updated December 16th, 2024, was distributed to all members of Council. Led by Council President Levon, the document was reviewed to determine whether items could be removed or needed to remain. As each Committee's tasks were reviewed, new items could be added. The document has been updated and attached for reference.

Mr. Levon noted he will check with Mr. Sack regarding:
Storm Sewers on Grand Boulevard (Committee of the Whole)
Ch1313.21 (Committee of the Whole)

Mr. Gerhardstein noted if City Vehicle Usage (Committee of the Whole) will be addressed in the new Policy Manual, he is okay with removing it from the list.

Mr. Stopp noted Golf Carts (Committee of the Whole) was in regard to driving them on the streets of the City.

Mr. Gerhardstein noted Crematoriums (Committee of the Whole) was with regard to the zoning aspect.

Mr. Levon noted that Potential TIFs (Finance Committee) could be reintroduced with regard to specific businesses if necessary.

Mr. Gerhardstein noted he has requested meetings on the topics of Gathering Spaces and Changes to Chapter 1303.70 Occupancy Permits (both topics – Legislation & Welfare) and Mr. Sack has not been prepared to meet on these topics. Mayor Sakacs noted he will speak to Mr. Sack regarding these topics.

Mr. Levon Suggested removing MS Consulting Updates (Economic Development/Euclid Avenue Re-development). Mr. Jaworski noted the Planning Commission continues to seek guidance regarding whether this document (the Euclid Avenue study) is the guideline for the Planning Commission. Mr. Gerhardstein noted he believe many of the items were covered in the overhaul of the zoning code earlier this year. Mr. Jaworski noted some items were addressed, but not all. Mr. Levon noted it will be left in, and asked that Planning Commission let Ms. Salotto know what questions are remaining. Mr. Jaworski noted he will discuss this with the Planning Commission at the February meeting.
