

ORDINANCE NO. 2025 – 18

**AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE NEW
2025 ASPHALT MAINTENANCE TRAILER
FROM CONCORD ROAD EQUIPMENT MFG. FOR USE BY THE SERVICE DEPARTMENT
OF THE CITY OF WICKLIFFE, OHIO; AND DECLARING AN EMERGENCY**

WHEREAS, various proposals were received for the purchase of one new asphalt maintenance trailer to be used by the Service Department of the City of Wickliffe, Ohio; and

WHEREAS, Council is advised by the Administration that it is necessary to acquire one new asphalt maintenance trailer to be used by the Service Department of the City of Wickliffe, Ohio.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized to purchase per quote from Concord Road Equipment MFG, 8200 Tyler Blvd., Suite H, Mentor Ohio, 44060, one new 2025 Asphalt Maintenance Trailer with requested equipment in a net amount not to exceed Forty-Four Thousand, Five Hundred Eighty Dollars and Seventy-Four Cents (\$44,580.74).

SECTION 2. That the Director of Finance be and is hereby authorized to issue payment to Concord Road Equipment MFG, 8200 Tyler Blvd., Suite H, Mentor Ohio, 44060, in an amount not to exceed Forty-Four Thousand, Five Hundred Eighty Dollars and Seventy-Four Cents (\$44,580.74) from the Capital Fund for said equipment upon approval of the Mayor.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city, and for the further reason that the purpose of said equipment is necessary for the daily operation of the Service Department of the City of Wickliffe, Ohio; wherefore, this ordinance provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
