

RESOLUTION NO. 2025 – 06

**A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF WICKLIFFE, OHIO
TO SUBMIT AN APPLICATION TO THE LAKE COUNTY OFFICE OF PLANNING &
COMMUNITY DEVELOPMENT FOR FUNDING THROUGH THE COMPETITIVE
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM;
AND DECLARING AN EMERGENCY**

WHEREAS, the Lake County Office of Planning & Community Development has made available funding for the competitive Community Development Block Grant Program (CDBG); and

WHEREAS, the City of Wickliffe has needed infrastructure projects for which funding is desired; and

WHEREAS, the City of Wickliffe wishes to submit an application in 2025 to secure CDBG funding; and

WHEREAS, in order to submit a request for funding, a resolution of authorization from City Council must be included in the filing of the application.

**NOW, THEREFORE, IT IS RESOLVED BY THE COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized to prepare and submit an application on behalf of the City of Wickliffe for Community Development Block Grant Program (CDBG) funding for the Wickliffe Cemetery handicap access ramp.

SECTION 2. That the Mayor be and is hereby authorized to execute such forms and contracts as may be required to properly secure said funding.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the city and its inhabitants; and for the usual daily operation of the City for the reasons set forth and defined in the preamble to this resolution; wherefore, this resolution, provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
