

RESOLUTION NO. 2025 – 15

**A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF WICKLIFFE, OHIO
TO SUBMIT AN APPLICATION TO THE DISTRICT SEVEN PUBLIC WORKS COMMITTEE
AND THE OHIO PUBLIC WORKS COMMISSION FOR FUNDING FOR THE
EUCLID AVENUE (U.S. 20) PAVEMENT IMPROVEMENTS;
AND DECLARING AN EMERGENCY**

WHEREAS, the State of Ohio has made available funding for infrastructure improvements; and

WHEREAS, acquisition of said funds is based upon project applications submitted to the District Seven Public Works Committee and the Ohio Public Works Commission (OPWC); and

WHEREAS, the City of Wickliffe has needed infrastructure projects for which funding is desired.

**NOW THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF WICKLIFFE,
COUNTY OF LAKE, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized to prepare and submit an application on behalf of the City of Wickliffe for OPWC funding for the following project:


EUCLID AVENUE (U.S. 20) AND PAVEMENT IMPROVEMENTS

SECTION 2. That the Mayor be and is hereby authorized to execute such forms and contracts as may be required to properly secure said funding.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said city, and for the further reason that the passage of this resolution is necessary in order to obtain funding from the District Seven Public Works Committee and the Ohio Public Works Commission; wherefore, this resolution provided it receives an affirmative vote of two-thirds (2/3) of the members elected to Council, shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
