Council President Gerhardstein noted he is looking forward to working with everyone. He thanked Councilperson Levon for his assistance with the transition.

He reminded Council that members must complete their financial disclosure information and their Sunshine Law training.

He noted he is looking forward to working on the budget, and stated he will be calling for a budget meeting at the January 12th Regular Meeting of Council. The Finance Committee meeting to discuss the 2026 Budget will be held Tuesday, January 20th. He asked all to consider if they would prefer a 6:00PM or a 7:00PM start time. The consensus was that 6:00 PM was preferred. The Council President noted he will officially call for this meeting at the Regular Council Meeting January 12th, 2026.

Councilperson Bala asked if the administration planned to continue the Storefront Program, noting it was not in committee. It was noted this can be discussed during the budget meeting, as there is a line item for this topic in the budget.

Motion by Levon, seconded by Koski, to adjourn the meeting.




