**Ordinance 729.03 Depositing of Snow on Public Streets or Private Property:**

- (a) Discharging or depositing of snow by truck, plow, blower or other snow removal equipment on any street, sidewalk or highway is PROHIBITED, except for accumulations which are necessary residuals of street or roadway cleaning operations by the City or other public authority.
- (b) Any person being owner, agent; operator, contractor, sub-contractor, entity in charge of any vehicle or equipment from which such substance has fallen, sifted, pushed or deposited upon the surface of public street sidewalk or highway in violation of this section, shall on direction of any member of Police, Fire, Service or City, **immediately remove** such substance form the street, sidewalk, (right of way), or highway.
- (c) No person, being operator of owner or in charge of any vehicle or equipment removing snow from private property, shall deposit the snow upon any property except that from which the snow is removed.
